He has advised governments and provided technical support to civil society and parliamentary committees on energy, mines and finance in Ghana, Liberia, Sierra Leone, Uganda, Tanzania, Senegal, South Sudan and Kenya. Before working in the Ministry of Energy, Amin Adam was the Founder and Executive Director of the Africa Centre for Energy Policy (ACEP). He also worked as an Energy Policy Analyst at the Ministry of Energy in Ghana, Commissioner of Ghana's Public Utilities Regulatory Commission, Deputy Minister of State for the Northern Region, and Mayor of Ghana's third city of Tamale. He was also the Africa Coordinator of extractives industries in lbis. He holds Board positions in the Open Contracting Partnership; the Natural Resources and Community Review, the Weston Oil and Gas Fund; and Zoil Oil Waste Services, among others.
